Power of the creditor to proceed against the guarantor when the debtor is under CIRP As per the Indian Contract Act, the liability of a guarantor and that of the principal debtor are co-extensive, thus a creditor is not obligated to expend the legal remedies against the principal debtor before making a claim against the guarantor and can sue either of them for the debt in no particular order .

Customers Who Fail to Pay Their Debts. When a business's customer fails to pay his or her debts, the business (as a "creditor" to which the debt is owed) has several available remedies to help collect the money from the customer (as "debtor"). These methods include remedies that do not require court involvement (called "self-help" remedies), and remedies that do involve the courts, discussed in more detail below.
